

New Hampshire residents all pay a county portion of their property taxes to their local government, which is passed on to the County in one lump sum each December. The tax rate is set by the county's legislative delegation during the annual budget process.

### **Register of Deeds**

The Registry of Deeds processes information as it relates to the selling and buying of real property. It is a public office open to the legal profession and general public for researching the records.

Candidates for this office must be 18 years of age and a registered voter in the county where you are domiciled, and must also be aware of other provisions of law regarding qualifications for Register of Deeds.

### **Register of Probate**

The Register of Probate oversees much of the work of Probate court that handles wills, trusts and estates, and guardianships.

### **Sheriff**

The Sheriff covers a wide range of responsibilities related to court services: prisoner transport, civil process service, court security, investigations and emergency communications. This office serves civil paperwork, arrest warrants and assists local city and town police departments with law enforcement duties and with public awareness campaigns and community programs.

## STATE OFFICES

### **Executive Council**

The Executive Council of the State of New Hampshire has the authority and responsibility, together with the Governor, over the administration of the business of the State. The council acts as a check and balance on the role of the governor.

They approve both receipt and expenditures of state and federal funds, budgetary transfers within the department and all personal service contracts with a value of \$10,000 and all contracts with a value of \$25,000.

There are five Executive Councilors who are elected every two years. A candidate must be 30 years of age, a registered voter, and domiciled in New Hampshire for at least seven years. The candidate must also live in the district he or she wants to represent.

### **State Senate**

The New Hampshire State Senate is the upper body of the New Hampshire State Legislature. There are 24 senators who are elected every two years. Nashua has two senators. District 13 represents the citizens in wards 3, 4, 6, 7, 8, and 9. District 12 represents the citizens in ward 1, 2, and 5, as well as Hollis, Brookline, Greenville, Mason, New Ipswich, and Rindge.

As New Hampshire does not elect a lieutenant governor, the senate president serves as "acting governor" whenever the governor is out of the state, or is otherwise unable to perform the duties of the office.

To be eligible to run for the Senate, a candidate must be 30 years of age, have lived in New Hampshire for at least seven years immediately preceding the election, and reside in the district from which he or she is seeking election.

### **NH House of Representatives**

The New Hampshire House of Representatives is the lower house for the New Hampshire General Court. The House of Representatives consists of 400 members coming from 204 districts, making it the largest lower house in the nation, and the third largest parliamentary body in the world. On average,

each legislator represents about 3,300 residents. In Nashua, each ward has three representatives.

In order to run for the House, a candidate must be 18 years of age, a registered voter, domiciled in New Hampshire for at least two years, and live in the town or ward they are running for.

## COUNTY OFFICES

Candidates for all county offices must be 18 years of age and a registered voter in the county where they are domiciled. Candidates must also be aware of other provisions of law regarding qualifications for that office.

### **County Attorney**

The County Attorney prosecutes felonies and misdemeanour appeals from the district courts. The office works in conjunction with the State Attorney General's Office, Sheriff's Department, New Hampshire State Police, and local police departments to prosecute crimes committed within each County. The County Attorney's Office also works directly with the medical referee in cases of untimely deaths.

### **County Commissioner**

County Commissioners are responsible for the governing, administration, and overall supervision of the department of corrections, nursing home, public assistance, human resources, and departments not under the statutory control of other elected officials. The Commissioners also have budget review over all county departments. There are three members of the board for Hillsborough County.

### **County Treasurer**

The County Treasurer collects the county property tax from municipalities, oversees financial accounts, and invests county funds. The Treasurer is the signatory on the county's financial accounts and works with the Business Office to maintain the integrity and security of all treasury funds.
