# Thinking ahead to the presidential primary---

**October 6, 2023** : **Friday**, the last day you may switch political parties before January's presidential primary.

**If you are an "independent" or "undeclared" voter, no action needed.** But if you wish to change from Dem to GOP or vice-versa, **October 6** is the last day you may do that for the January presidential primary. Not sure how you're registered? Check it out online at this Secretary of State webpage: <u>https://app.sos.nh.gov/voterinformation</u>

This is important if you voted in a primary in 2022, when you had to declare a party to get a ballot. Did you switch back to "undeclared" afterward? If you think you are "undeclared" but want to be sure, check your status at the same webpage. **Visit your town clerk or local meeting of the supervisors of the checklist to change your party. Bring ID.**
