The upcoming City Election will determine
Dover's elected leadership for 2026-27.

All voters will cast ballots for a Mayor, two
At-large City Councilors and one At-large
School Board member. In addition, voters
will select a City Councilor and a School
Board member to represent their Ward as
well as election officers: a Supervisor of the
Checklist, Moderator, three Selectpersons,
and a Ward Clerk.
